Doosan's lift truck history

Korea's initial home-based lift truck market was an open-import enterprise. In the 1960's, Korea Machinery Co. Ltd. started to import assembled lift trucks as part of a national machinery expansion venture. Early product sales of this manufacturing equipment focused on large business communities, the armed forces and on state-run firms. This eventually led to a unification with Daewoo Heavy Industries Ltd. In 1976, the Forklift Division begun business operations throughout Korea to overhaul and sell this heavy equipment. By 1978, a forklift manufacturing plant was successfully completed. Continuous technical education grew to become the new focus for improving quality and product development.

Lift Truck Export Expansion

Home-based lift truck trade for Daewoo started in 1967 and grew to an amazing 90% market share in Korea. By the 1980's, Daewoo's progressive technological advancements combined with sales success placed them in a situation of considerable expansion of their forklift operations.

In 1981, Caterpillar Industrial Inc. of the United States, proposed a joint venture project to counter act competitive pressures in the US materials handling market. This plan radically expanded Daewoo's forklift sales. Construction was finished in 1984 to facilitate a contemporary plant which helped establish the company for the fabrication of high added-value products suitable for export. In 1993, the company had a global sales system and started exporting designs they had developed through in-house expertise, as an sovereign product. Certifications were then acquired from CE of Europe, UL of the United States and ISO 14001 and ISO 9001, securing expansion possibilities into overseas marketplaces.
